**QUESTIONED
BALLOTS**

The Canvass Committee reviewed the questioned ballot list that was provided by the clerk.

BULARD MOVED to reject number 1 because they are registered in Willow. Number 2 is not a registered voter. Number 6 is registered in Healy/West Central Ballot but voted at Clear a North Ballot. Number 7 is registered in North Pole. Number 9 and 10 are registered in Healy/East Central Ballot but voted a West Central Ballot. Number 11 is registered

Anderson/North but voted Healy/West Central Ballot. Number 12 is registered Denali/East

Central Ballot but voted Healy/West Central Ballot. Number 14 is registered in Fairbanks. Number 17 is not registered to vote in the state of Alaska. Number 18 is registered Denali/East Central but voted in Healy/West Central Ballot. Number 20 is registered Denali/East Central but voted Denali/West Central Ballot. Number 21 is registered in Anchorage

The clerk noted that there was not an East Central Ballot this year. Winklmann seconded. The VOTE was unanimous.

WINKLMANN MOVED to accept numbers 3, 4, 5, 8, 13, 15, 16 AND 19. Kohlsdorf seconded. The VOTE was unanimous.

The ballots will be placed with the absentee ballots to count them simultaneously.

ABSENTEE BALLOTS

The committee reviewed the absentee ballot list provided by the election clerk.

Number 1 on the list of the East Central District voted a South Ballot. The East Central did not have a ballot this year. KOHLSDORF MOVED to reject number 1. Winklmann seconded. The VOTE was unanimous.

The absentee ballots were removed from the white identification envelope. They were removed from the secrecy sleeves placed in the ballot box along with the approved questioned ballots and then tallied for each district except the South District.

The clerk stated that there was only one absentee ballot from the South District. KOHLSDORF MOVED to not count the absentee ballot from the South District because it would be the only ballot in the ballot box and therefore would disclose the vote of the voter and by not counting would not change the outcome of this election. Winklmann seconded. The VOTE was unanimous.

The totals were placed into the Preliminary Report.


