 INTRODUCED BY: ASSEMBLY MEMBER BAXTER MERCER

AN ORDINANCE PROVIDING FOR THE ESTABLISHMENT AND ADOPTION OF THE
 CLASSIFICATION OF BOROUGH MUNICIPAL ENTITLEMENT LAND.

BE IT ENACTED by the Assembly of the Denali Borough, Alaska that:

Section 1. Classification. This is a non-code ordinance.

Section 2. Purpose. The purpose of this ordinance is to classify Denali Borough Municipal Entitlement Lands located within the Panguingue Creek Subdivision.

Section 3. Authority.

Section 4. Borough Assembly Finding. Based on the Findings of Fact and recommendation from the Denali Borough Mayor and the Denali Borough Planning Commission for the classification of these lands under Denali Borough Management Authority Status, the Denali Borough Assembly classifies these lands located within the Panguingue Creek Subdivision as follows:
