**ABSENTEE  
BALLOTS**

The committee reviewed the absentee ballot list provided by the election clerk.

The clerk stated that there was only one absentee ballot from the south district. HALL MOVED and HOLMES seconded to not count the ballot from the south district because it would show what the voter voted and by not counting the ballot, would not change the outcome of the election. The VOTE was unanimous.

The absentee ballots were removed from the envelopes and placed in the ballot box.

TALERICO read the ballots while the committee tallied the votes. TALERICO questioned one ballot that had a name scratched out and another name marked. The clerk stated that the committee should decide if they know the intent of the voter. HOCKIN MOVED to accept the ballot because the intent of the voter was to vote for the name that was marked in the box excluding the name that was scratched out. KOHLSDORF seconded. The VOTE was unanimous.

**QUESTIONED  
BALLOTS**

The Canvass Committee reviewed the questioned ballot list.

HALL MOVED to accept numbers 2, 6, 7, 10 and 14. BULARD seconded. The VOTE was unanimous.

HALL MOVED to exclude 1, 3, 5, 8, 9, 11, 13, 17 and 18 because they are not registered to vote in the Denali Borough. KOHLSDORF seconded. The VOTE was unanimous.

BULARD MOVED to exclude numbers 4, 12 and 15 because they are registered to vote an east central ballot but voted a west central ballot. KOHLSDORF seconded. The VOTE was unanimous.

HALL MOVED not to count north district ballot number 16 because it would be the only ballot in the ballot box and would thereby disclose the voters vote and by not counting would not change the outcome of the election. HOCKIN seconded. The VOTE was unanimous.

Question ballots 2, 6, 7, 10 and 14 were removed from the affidavit envelope and placed in the ballot box. TALERICO read off the votes while the committee tallied.

HALL MOVED to combine the name Tom Wright with Thomas Wright and KOHLSDORF seconded. The VOTE was unanimous.

HOCKIN MOVED to combine the name Kay Hockin with Virginia K Hockin. HOLMES seconded. The VOTE was unanimous.

RECESS The committee recessed at 7:30 PM.

RECONVENED The committee reconvened at 7:50 PM.

Mayor TALERICO read the final results into the record.
