AN ORDINANCE CREATING DENALI BOROUGH CODE OF ORDINANCES TITLE 10, TITLED VEHICLES AND TRAFFIC, ALLOWING FOR PERMANENT REGISTRATION OF MOTOR VEHICLES OLDER THAN EIGHT YEARS AND FOR PERMANENT REGISTRATION OF NON-COMMERCIAL TRAILERS

BE IT ENACTED by the Assembly of the Denali Borough, Alaska that:

Section 1 Classification. This ordinance is of a general and permanent nature.

Section 2 Purpose. The purpose of this ordinance is to create Denali Borough Code of Ordinances Title 10 to be titled Vehicles and Traffic and to create Chapter 10.01 titled Motor Vehicle and Noncommercial Permanent Registration as follows:

**Chapter 10.05**

**PERMANENT MOTOR VEHICLE AND NONCOMMERCIAL TRAILER REGISTRATION**

Sections:

- 10.05.010 Purpose
- 10.05.020 Authority
- 10.05.030 Motor Vehicle Registration
- 10.05.040 Noncommercial Trailer Registration

**10.05.010 Purpose**

The purpose of this ordinance is to establish a permanent registration for motor vehicles older than eight years and permanent registration for non-commercial trailers.

**10.05.020 Authority**

Alaska Statutes 28.10.108(a), 28.10.155, 28.10.411(f), 28.10.421(J)

**10.05.030 Motor Vehicle Registration**

To the extent authorized and permitted under state law, the owner of a motor vehicle may register the motor vehicle permanently if the owner resides within the Denali Borough.


**10.05.040 Noncommercial Trailer Registration**


To the extent authorized and permitted under state law, the owner of a noncommercial trailer may register the trailer permanently if the owner resides within the Denali Borough.

Section 3. Effective Date. This ordinance becomes effective 30 days upon adoption of the Denali Borough Assembly and signature of the Denali Borough Mayor.
